2. **Submit a copy of your 2025 Federal Tax Form (1040) with the application. If parent is not required to file taxes, please provide IRS verification letter, by calling 1-800-829-1040 OR www.irs.gov/individuals/get-transcript.**
3. Applications are not accepted by fax or email.
4. Any previous account balances must be paid in full.
5. After Tuition Assistance has been determined, an award letter will be sent by USPS mail within 7–10 days outlining the remaining balance due. To expedite payment, an invoice will also be emailed. Payments may be made using the emailed invoice, by phone, or in person.
6. **Students may not begin programs until Tuition Assistance has been determined and the invoice has been paid.**
